 To support continuity of care for veterans within VA Palo Alto Addiction Treatment Services (ATS), we launched the "Mental Health/Addictions Volunteer +

Methods/Approach

- Summer 2022: Program development starts
- September 2022: Recruited volunteers through established email lists and academic
- department channels. Identified needs within the VAPAHCS Addiction Treatment Services which
- volunteers could address, such as developing an online database of local SUD treatment resources, assisting veterans with telehealth access and technology, and conveying harm reduction materials to
- Created educational material for volunteers centered on: (1) Principles of Addiction Medicine, (2) Multimodal addiction treatment,

and (3) Care of Veterans.

Applicants and Accepted Volunteers

Results

- 15+ volunteers accepted from ~25 applicants
- Accepted volunteers received preliminary training on addiction medicine, VAPAHCS, and VA ATS responses
- Volunteers began work in January 2023 Volunteers have completed 8+ hours of work/month
- Preliminary feedback indicates volunteers' desire for direct engagement with clinicians and veterans and for internal leadership and advancement opportunities
- Persistent logistical challenges of onboarding students to the VAPAHCS volunteer system

- other VAPAHCS staff. Design workflows to streamline volunteer
- onboarding and scheduling processes • Promote diversity, equity, and inclusion in volunteer recruitment to better serve veterans
